

## **TERMS AND CONDITIONS OF STEAMER INSTALLATION**



### ***Conditions of Installation (Personal Guarantee) Appendix 'A'***

1. Supplied machinery always remains property of Sai Asia International (ACN 113625522).
2. The site operator and person signing this agreement undertake to insure the machinery whilst under their control and is personally responsible for the safe keeping of machinery/equipment.
3. The site operator and the person signing this agreement undertake to clean and maintain the machinery/equipment whilst under their control in accordance with Sai Asia Intl P/L T/A Boss Hogs Hot Dogs requirements and instructions. A \$110.00 + GST cleaning surcharge/fee will be charged for any dirty/unclean machines/equipment. In addition, any damage to the machinery is the responsibility of the site operator and person signing this agreement and he/she will be liable for any charges related to any burnt out elements, broken glass, other damage or loss. This may or may not be as a result of deliberate misuse of the equipment. The site operator and person signing this agreement will ensure no employee or other person will alter, interfere with or modify the machinery/equipment and all persons using said machinery and equipment agrees to comply in accordance within NSW State and Australian Federal food handling and storage regulations. The site operator takes all responsibility for any incident involving the equipment and products supplied and have their own current and valid public liability insurance. Sai Asia International T/A 'Boss Hogs Hot Dogs' accepts no responsibility for any legal action taken by any person using our equipment or products and the site owner/operator accepts all liability and will pay all costs.

#### **ONLY PRODUCTS SUPPLIED BY BOSS HOGS HOT DOGS ARE TO BE USED IN STEAMERS.**

4. All stock and equipment remains the property of Sai Asia International until payment is cleared in full. This agreement is for all and any of our supplied equipment and products.
5. Payment is to be made on agreed terms of 14 days and any amount outstanding past these terms may be passed to a third party for collection. Such collection costs or other legal expenses will be the responsibility of the site operator/person signing this agreement.
6. Site operator will pay an additional \$110.00 administration fee if less than 8 orders are placed annually. Accounts must be paid in full upon termination of this agreement and return of the machinery.
7. Products supplied by Sai Asia International P/L are the only products to be used in Boss Hogs machinery and equipment or a \$250.00 + GST fee will be payable. If the site operator does not order for more than 2 months from the last order a \$33.50 + GST per week hire fee from the last order will apply.
8. The site operator or person signing this agreement is responsible for safe keeping of any Point of Sale (POS) promotional items. Any lost, stolen or damaged promotional items will incur a minimum \$66.00 fee. The site operator or person signing this agreement will be responsible for the cleanliness of any/all POS material. Lost or damaged 'A' Frames incur a \$185.00 fee.
9. The site operator or person signing this agreement assumes all liability for any loss incurred by Sai Asia International and agrees to pay all legal costs, related and other expenses for any action taken by Sai Asia International or any other third party acting on their behalf.
10. Double Decker \$880.00 & Drainage Kits \$65.00 must be paid for if lost, stolen &/or damage.
